Total Assessment Amount	ENF_MILESTONES_TOTAL_AMT	Money	For monetary enforcement actions, such as Administrative Civil Liabilities, this is the amount being assessed by the enforcement actions, including both through liabilities and through projects. The amount assessed can change between initial issuance of an

			enforcement action and the final agreement between the Water Board and the responsible party due to negotiations or Board action.
Initial Assessed Amount	ENF_MILESTONES_INITIAL_AMT	Money	For monetary enforcement actions, such as Administrative Civil Liabilities, this is the amount being assessed by the enforcement actions, including both through liabilities and through projects. The amount assessed can change between initial issuance of an enforcement action and the final agreement between the Water Board and the responsible party due to negotiations or Board action.
Liability \$ Amount	ENF_MILESTONES_LIABILITY_AMT	Money	For monetary enforcement actions, such as Administrative Civil Liabilities, this is the amount owed to the Water Board.
Project \$ Amount	ENF_MILESTONES_PROJECT_AMT	Money	For monetary enforcement actions, such as Administrative Civil Liabilities, this is the value of the project that the enforcement action requires.
Liability \$ Paid	ENF_MILESTONES_PAID	Money	This is the amount that has been received by the Water Board to be applied towards the assessment.
Project \$ Completed	ENF_MILESTONES_PROJECT_COMPL	Money	This is the value of project that has been implemented, as required by the enforcement action.
Total \$ Paid/Completed	ENF_MILESTONES_TOTAL_PAID	Money	This is the total amount paid toward the required liability amount and the value of the project completed.
